# **Privacy Policy**

### **POLICY STATEMENT:**

Rockingham Pest Control respects and upholds individual's rights to privacy protection under the National Privacy Principles contained in the *Privacy Amendment (Private Sector) Act 2000 (Comm)*.

All information held by Rockingham Pest Control (in hardcopy or electronically) will be maintained in a safe, confidential and private manner.

#### **HOW YOUR PERSONAL INFORMATION IS HELD:**

Your personal information is held in client files and/or a computer database.

Rockingham Pest Control is committed to ensuring that we take reasonable steps to ensure that the personal information that we hold is protected from misuse and loss and from unauthorised access, modification and disclosure. ## **HOW WE USE YOUR INFORMATION:**

Rockingham Pest Control uses personal information belonging to our clients:

Rockingham Pest Control will destroy or de-identify personal information after its legal obligations to retain the information have expired.
